Admission Standards for International Students – First-Year Applicants

Academic Preparation

First-year students must have earned the equivalent of a US high school diploma. Their secondary education should include the equivalent of at least 28 college preparatory high school courses, and a grade point average that is the equivalent of a 3.0 on a 4.0 scale. Students who are not eligible for full admission may be considered for conditional admission.

Standardized Test Scores

If you have graduated from secondary school within the last two years, IU Southeast requires official scores on the SAT or ACT.

Admission Standards for International Students – Transfer Applicants

College/University Record

If you have completed at least one year of full-time university studies, you will be considered a transfer student. Admissions decisions will be based on grade trends, your cumulative and recent-term grade point averages (GPA), and the breadth and depth of your college program. Transfer students should have the equivalent of a 2.0 GPA on a 4.0.

Applicants who have not completed a year of university must submit secondary school records in addition to their university transcripts.

IU Southeast accepts the following as proof of English proficiency for undergraduate programs:

- A score of 530 or higher on the paper version of the Test of English as a Foreign Language (TOEFL)
- A score of 197 or higher on the computer-based TOEFL
- A score of 71 or higher on the internet-based TOEFL

- Provide documentation of financial support.** Nonimmigrant international students must present proof of financial support to show that sufficient funds are available to cover all study and living expenses for the first year of study at IU Southeast.
